- WHEN: Main Pool during normal Pool Hours of **Operation EXCEPT 11-3PM WEEKENDS and HOLIDAYS. SKYBROOK NORTH there will be no parties on weekends until after July 10th.** During your pool party, the pool will NOT be closed to other members. After hour parties are available by request depending on guard availability (must be reserved and deposited). No Pool Parties during Holiday Weekends.
- Only club members are permitted to rent the pool for functions. NO EXCEPTIONS
- Parties of more than 12 will require additional pool guards, also chaperones must be present for children and teen parties of 1 to 10 kids.
- If the Renter elects to cancel, notice MUST be received TEN (10) days prior to date of event. There is no charge, otherwise the Deposit is forfeit.

1. Please arrive 30 minutes prior to party time to allow for set up and plan on 30 minutes for clean up after. All parties must be cleaned up immediately after scheduled function. All trash is to be moved to red dumpster in club parking lot. All personal items (food, decorations, and beverages) must be removed at the end of party.
2. Renter assumes liability for all damage to the pool area, equipment, restrooms and injury to the pool staff arising during the event.
3. Renter will assume all financial responsibilities for damage, parties for children and teens must have chaperons (1 to 10).
4. Skybrook Pool and Racquet Club is not liable for any items left behind.
5. Renter assumes all personal injury liability for guests during the event.
6. Violation of any Skybrook Pool and Racquet Club rule may result in termination of rental.
7. NO GLASS containers are allowed in the pool area.
8. Pool rental does not include use of the fitness area, clubhouse rooms, grill or tennis courts.
9. Guests must park in designated lined spaces.
10. Renter will ensure guests are responsible and considerate of homeowners, especially ones in close proximity to the club, with regards to use of music and constant noise levels.
11. Renter acknowledges that the Skybrook Swim and Racquet Club owners and/or management reserves the right to cancel any function prior to commencement for reasonable cause.
